Hello Cowboys and Cowgirls,







I was also happy to assist Ron Trusley as the AGRA Alternate Trustee for Liberty Stampede. Ron was able to attend the IGRA Board Meeting on Friday, but had to get home to tend to some important business.

Due to severe weather, and the ambulance having to leave our Rodeo on Sunday to help the local townspeople deal with sever flooding, the Trustees and Stock Contractor agreed to cancel the Sunday Performance following the Women's Calf Roping On Foot. It rained for 3 hours non-stop with lightening, and we watched the arena dirt literally wash away to the creek. Many of the local roads in and out of the Facility were also washed out.

An excerpt from our bylaws as an educational opportunity: Many of our 2010 elections and nominations are coming up in the next few months. I have only listed those sections that pertain to the upcoming nominations, and elections.

#### ARTICLE VI A.G.R.A. VOTING AND ELECTIONS

#### **6.4 Nominations**

- A) Nominations for the Board of Directors, except the Trustee, shall be received at each membership meeting in **October and November** of each year.
- B) Nominations for the I.G.R.A. Trustee shall be received at each membership meeting in **September and October** of the year in which the current Trustee's term of office expires.
- D) Names of all nominees shall be submitted to the Election Committee no later than thirty (30) days prior to the beginning of the scheduled election.

#### 6.5 Qualifications for the A.G.R.A. Board of Directors

A) President: Must have been an individual member or individual champion member at least twelve (12) months when nominated B) All other board positions: Must have been an individual member or individual champion member at least six (6) months when nominated

#### 6.6 Election of the Board of Directors

Election shall be held for all board positions, except the Trustee, in December of each year. Voting shall be by members present at the December membership meeting. Election of the Trustee shall be held in November of the year prior to the Trustee's term of office expiration. Voting shall be by members present at the November membership meeting.

#### 6.7 Term of Office

Each Director, except the Trustee, shall be elected for a one-year term. Each term shall begin on February 1 of the year following elections. The Trustee's term of office shall be for three years, beginning January 1 in the year following election and ending December 31 three years later.

#### **6.8 Election Committee**

The Board of Directors in March of each year shall appoint an Election Committee which shall consist of three (3) members. The Election Committee shall:

- A) Select an Election Committee Chairperson
- B) Prepare a written ballot listing all of the nominees for each office, by office
- C) Supervise the conduct of the voting
- D) Tabulate the votes and publish the results
- E) Certify the election of officers to the membership
- F) Committee shall remain a neutral body and not make recommendations
- G) No member of the committee may be nominated for a Board position and continue to serve on the Election Committee

#### 6.9 Elections

Elections for the Board of Directors and all other voting shall be conducted by the Election Committee appointed by the Board of Directors in March of each year. (Refer to Article IV, Section 4.1.C for specific duties.)

#### **6.10 Election Majority**

Fifty percent plus one (50% plus 1) of eligible votes cast, excluding abstentions, shall be required for election to any board position and to be declared a winner on all other ballots cast.

#### 6.11 Run-Off Elections

In the event there are three or more persons nominated for an office and no individual receives 50% plus one votes of the eligible votes cast, a run-off election shall be held between the two persons receiving the highest number of votes. The Election Committee shall announce a run-off election is required, and the run-off election shall be held in the same meeting. The Election Committee shall distribute new ballots to members who voted in the original election, and thoroughly explain the voting process. Only those members who voted in the original election will be allowed to cast a run-off ballot.

#### 6.13 Election Records

Following the completion of the election of the Board of Directors and Trustees and any other voting by ballot, the Election Committee shall immediately forward all records and ballots to the Secretary. The Secretary shall retain the ballots in the Corporation.

As I reported in the August 9 Membership Meeting the IGRA archives were being taken to Autry Museum in Los Angeles where they will be kept. Tommy Channel and Patrick Terry drove from Denver to Los Angeles with the 25-years collection of IGRA archives and arrived safely with all of the archives.

Andrew Goodman, IGRA Vice President, along with a delegation from the GSGRA (Golden State Gay Rodeo Association) were present when the archives were received at the Autry Museum. Please see photo in this Branding Iron issue. In an August 11 email from Gregory Hinton, Project Coordinator, to Andrew, he wrote: "The Autry was blown away by you all. Thank you for coming today. Next stop, the IGRA archives."

On August 14 Gregory wrote in an email to Brian Helander, IGRA President:

"Patrick and Tommy just drove away. The IGRA archives are safely tucked away with the Autry Registrar. Marva Felchlin, Director of the Autry, personally received them and went through in detail the care they would receive, the importance of them to the collection and the value of them to scholars in the future. It was very moving, knowing they came from Denver, where I came out in 1975. It was so much fun to be young. Thank you for everything, Brian. With much affection, Gregory"

Tommy Channel also sent an e-mail to the IGRA Board of Directors in which he wrote:

"I wanted to let you know that our adventure out to L.A. this past weekend was indeed worth the trip. Patrick and I were very excited to visit the Autry Museum where the IGRA archives will be stored. We found a great group of folks who were very excited to receive the documents and enter IGRA into the museum. This will be a great source of research for anyone who wants to learn about IGRA and it will be monumental when an IGRA exhibit is made available to the public. Thanks to everyone who supported this effort. Thanks to Gregory Hinton and Patrick for organizing the archives for transfer to the museum."

Also, in the August 9 membership meeting, members voted to take a sponsorship for the 2010 IGRA Annual Convention (Silver Anniversary). The vote was to sponsor a coffee break and a ¼ page program ad for \$375.00. I was advised that the coffee break sponsorship includes a ¼ page program ad, so I am waiting to hear from CCGRA (host association) where they might most need to apply the extra \$75.00. Perhaps, our ad will be expanded to a ½ page ad. Also, if you are going to convention, I suggest you make hotel reservations now; the reservation cut-off date is 5 pm October 21.

At the 2009 IGRA Convention, 10-year IGRA Royalty will be acknowledged. AGRA had 2 people on the 2000 IGRA Royalty Team who will be acknowledged. They are Erika Alexander-3<sup>rd</sup> Runner-Up Miss IGRA and Lacey Edwards-2<sup>nd</sup> Runner-Up Ms IGRA.

IGRA has received a Federal registered trademark for the words "World Gay Rodeo Finals" ®. At the appropriate times, applications will be submitted to trademark the words IGRA and IGRA University and eventually to copyright all logos.

I would like to remind everyone per AGRA Bylaws, nominations for Trustee will be received in the September 27 and October 11 membership meetings and voting will take place in the November 8 membership meeting. The Trustee will be elected for a 3-year term – January 1, 2010 through December 31, 2012. The Trustee is AGRA's representative to IGRA and serves on the IGRA Board of Directors.

In the August 9 membership meeting, profits from the 2009 Road Runner Regional Rodeo were given to 5 different organizations voted by AGRA members. Total amount of checks to these 5 organizations was \$4,800.00. Organizations benefiting from these profits were:
