# STABLE VICES AND OTHER BAD HABITS

Horses in confinement often develop habits that may be annoying to their owners and even harmful to themselves. Most stable vices result from sheer boredom.

"Bolting" is a horse's habit of eating its conentrate feed very rapidly and without chewing it properly.

"Cribbing" irefers to a condition in which the horse bites the manger or another object while sucking in air. It sometimes causes a bloated condition. and the horse is more likely to develop colic. This condition may be remedied by buckling a strap snugly around a horse's neck in such a way that it compresses the larvnx whin the neck is flexed or extended. If properly placed, such a strap will cause no discomfort at other times.

"Halter pulling" refers to the habit of pulling back on the halter rope or bridle reins when tied. The halter or strap may be broken, allowing the horse to run away.

Some horses develop a habit of "kicking" or "striking" the stall or other objects with their rear feet. They apparently do this for the satisfaction derived from striking something.

"Tail rubbing" is a habit of persistently rubbing the tail against the side of a stall or on another object. This may result from parasites.

"Weaving" is a condition in which a horse weaves, or sways from side to side, while standing in a stall.

horses may develop the Draft "balking" habit of when hitched to heavy loads. Thus they refuse to push their shoulder against the collar. Such a habit sometimes develops because of a poorly litting collar. which causes a sore on their necks or shoulders.

A horse may develop the habit of "rearing" on its hind legs when an attempt is made to lead it. Others may rear mounted. Some horses When develop the habit of "striking out" with the forefeet when they are being led and/or when they rear up on their hind legs. Other horses develop a habit of shving when ridden and may even unseat their rider. Draft horses sometimes develop the dangerous habit of running away when hitched to a wagon or other moving vehicle. Tiding horses, especially cow ponies, may "cold-jaw". a habit of taking the bit in their teeth and running at top speed. Pulling on the reins other methods commonly used in stopping them are often unsuccessful. Once these runaway habits develop.m little can be done to correct them.

Another undesirable habit horses develop is that of playing "hard to catch" when their owners try to drive them into a stable or catch and bridle them in a pasture or pen. Other horses object to being harnessed or saddled. Gentle horses may develop the habit of expanding their chest cavity (breathing deeply, commonly called swelling up) when the saddle cinch is tied or buckled. They exhale air after the cinch is fastened and thereby cause the saddle to be loosened.Some COW

ponies. probably because of the manner in which they are first broken and handled, develop the habit of bucking. This habit marks some horses 35 unsuitable for riding: seem gentle but they others may "break in two" and throw their riders when least expected.

Most vices (bad habits) of horses are difficult to correct once they are developed. Preventing the habit is much more desirable than trying to corret it. older horses, however, can be broken of many undesirable habits and taught new tricks. should be remembered that It. are not horses generallyt considered pals. as is often the relationship of dogs to Rather, horses must be man. taught to serve and respect their master.

# CARE AND TRIMMING OF THE FEET

A majority of horses are presently kept for either riding or driving purposes. These uses involve movements of various kinds, and proper movement is dependent upon healthy and sound normal feet. In fact, many movement defects among horses are related directly or indirectly to improper care and trimming of the teet. Therefore, horse owners should care for the hooves of their horses in a proper manner and use the services of professional a when appropriate. Tools most often used to trim the feet include hoof nippers. a hoof knife, а hoof pick, and a rasp. Properly and improperly trimmed hooves are shown in the figure below.

Proper care of feet starts with the voung foal. An hoof causes uneven unshapely wear and may result in unsound legs. Faulty legs can often be corrected by proper trimming of the hooves: however, it 15 more desirable to keep hooves trimmed as a properly prophylactic measure against The unsoundness. sucha D toal's feet should be observed while it is standing on a hard and then when in surface action, both at a walk and at a trot.

The hoof of a normal healthy horse grows about 1/2 inch monthly. If the ground is




Fig. 20.5 Trimming horse feet. (a)Properly trimmed hoof with normal foot axis: (1) coffin bone, (2) short pastern bone, (3) long pastern bone, (4) cannon bone. (b) Toe too long, which breaks the foot axis backward. Horizontal dotted line shows how hoof should be trimmed to restore normal posture. (c) Heel too long, which breaks the foot axis forward. Horizontal dotted line shows how trimming will restore the correct posture. (USDA.)

mostly soft and the hoof is not trimmed. the wall will break off and wear unevenly. Under such conditions the hoof should be trimmed monthly Nippers may be used to trim the horn, and the wall may be leveled with a rasp. If the hoof is uneven. it may be necessary to correct this over a period of time with several trimmings. The frog of a foot should also be carefully trimmed by removing the ragged so that dirt edges or other will extraneous matter not accumulate in the crevices. Since it serves as a cuchion for the hoof, the frog should be trimmed excessively. not The sole should be trimmed little. it anv. It. 15 recommended that the outside walls of the hoof not. be rasped. since this removes the outer protective layer which normally prevents evaporation.




Fig. 20.6 Parts of a horse's foot. (a) Bearing edge and hoof wall; (b) sole; (c) median furrow of the frog; (d) lateral furrow of the frog; (e) apex. of the frog; (f) branch of the frog; (g) bar. (USDA.)

The bars (either of the recurved ends of the wall of a horse's hoof where they curve in to the sole)should never be trimmed below the level of the walls. Frequently, the novie trims these excessively, which allows the wall to collapse inwardly and thereby pinches the lateral cartilage.

shoes are a necessity when horses pull loads or ridden on hard surfaces. Otherwise. the hooves wear down, the feet become tender, and lameness results. Cow ponies worked on the range, especially in rocky ground. must be shod. Shoes of a proper size should be used for each horse. They are shaped to fit the contour of the hooves. When nailing on a shoe, care should be taken not to drive the nail into the "quick" or sensitive, part of the hoof. When nailed through the hoof, the sharpo ends of nails should be twisted offf. and the remaining blunt ends tapped lightly to bend them downward and thereby hold the shoe firmly in place. Shoes are commonly replaced or reset at intervals of 4 to 8 weeks. Those worn too long may allow the hoof to grow out of proportion and thereby throw a walking or running horse off balance. Corrective shoeing to relieve an abnormality requires skill.

# GET YOUR CHECK LIST READY FOR AUSTIN

Colorado law states-You must have a brand inspection before moving your horses from state to state. For many of us a permenate brand inspection is more practical and can be obtained from the Colorado Brand Board 2940895, The brand inspection is title to your horse and allows you to travel without a lot of A.Q.H.A. paperwork. It takes a week to receive a permenate, but a regular brand inspection is given immediately. The fees are \$5.00 per owner, \$0.30 per horse, and a permenate inspection is \$10.00 more.

When buying a horse in Colorado, a brand inspection must be done before ownership is recognized and this insures buyer and seller that the said horse is legally the horse in question. We have all been VERY lucky that we have never been impounded while trasveling, so let's not push our luck. A Coggins Test and Health Certificate is equally important and necessary when hauling horses.

A Run-thru on the trailer is necessary, for the drivers and horses' safety (i.e., brakes, lights, tires and spare for the entire rig). There should be bedding inside the trailer to ease the impact of the long haul on the horses legs. Leg wraps or shipping boots are a must as well as a sheet or blanket. Tail wraps are optional.

Electrolites should be started a week to 10 days prior to the haul, and carried out throughtout the trip. Let's avoid dehydration in Austin!

A quick check on equipment should be done to insure the riders and horses' safety during proformence. Be sure to have head stalls. reins blankets or pads, and saddle wear. Be sure to check your leggins and stirrup restraints. Having an extra pair of reins and a extra headstall is good for a backup, incase of breakage. Horses drink 10 to 30 gallons of water a day; don't forget a couple of buckets per horse.

It vou are planning to use aliota pellets instead of hay. U ansition should start at least 10 days prior to travel. Ask vour vet about the quantity of the pellots to be used instead of the hay. Hay bags during travel also helps to relieve a horse's bordom.

# RIDING THE CANTER OR "LOPE"

The canter is a most enjoyable gait, easy and rhythmic. It is the slow, collected form of the gallop. It is a three beat gait, and the horse is said to canter on the left or right lead.

On the right lead, the horse starts his canter with the left hind leg, then the right hind leg and the left fore leg hit the ground together. and finally the right fore leg which become the leading leg. There is a interval of suspension after the three beat when all tour feet are off the ground. The second beat is a little longer than the others. On the left lead. movement starts with the right hind leg, then the left hind and right fore together.then the left fore.

The canter is a rockingchair gait. Therefore, the rider uses the full seat. The best way to learn the canter is to ride without stirrups because many riders put too much of their weight in the stirrups. This throws them up and out of the saddle when they are to be firmly seated. The back muscles do most of the work and the rider doesn't leave his saddle.

Have a freind canter in front of you then urge your horse into a canter by loosening the reins and pressing your heels against the horses sides. When he is moving smoothly and steadily. take your fet from the stirrups and put your hands on the halter shank or rest them on the pammel. Your weight is on your setting bones and you swing with the motion of the horse. This brings your all important lower back muscles into play.

When you are sure of your seat and the rhythm, canter without the reins, placing your hands on your waist or across your chest.

You may use your stirrups when you are able to canter without bouncing. It may help to lengthen them a little because you do not want to put any pressure on them.

One very common fault in riding at the canter is to push back in the saddle with the legs thrust forward. As in the trot, this position is unbalanced and leaves the rider behind his horse. The rider whose elbows slap around is also out of balance.

I.G.R.A. FINALS RODEO - RENO

The following article is a run down on the events leading up to and following the cancellation of the I.G.R.A. Finals Rodeo in Reno, Nevada as related to S.S.G.R.A., I.G.R.A., other State Associations, contestants and spectators.

FACT #1: The Lawler Events Center in Reno, which is operated by the University of Nevada booked the I.G.R.A. Finals Rodeo. However, they (the Lawler Events Center) claimed that the S.S.G.R.A. did not pay for the use of the center in time and therefore the rodoe association could

not use the facilities. S.S.G.R.A. took the Lawler Events Center to court. but the judge ruled that because of the way this particular contract was handled. that the center had the right to cancel the contract. The judge suggested that S.S.G.R.A. pay the contract in full in order to re-activate it, which S.S.G.R.A. did within a 24 hour time period. However. when S.S.G.R.A. went to pay the balance of the contract to the Lawler Events Center: suddenly the facilities where no longer available. A basketball PRACTICE had been scheduled by none other than the University of Nevada's basketball team.

FACT #2: The A.C.L.U. of Nevada is filing a suit against the Lawler Events Center on behalf of the S.S.G.R.A. However, this suit will only be filed following the filing of all other suits which are in process. There will be more information on this as it becomes available.

FACT #4: Church Hill County accepted a \$300.00 payment for the use of their arena, which was collected the NEXT day by a county commissioner. However, this proved to be another blind road.

FACT #5: With the picture dim, looking emergency facilities, became available. The Landry Roping Arena; which 15 privately owner and operated, became available to us and a contract was signed. When the Landry Arena applied tor a liquor liscense, the public of Fallon and Church Hill County became aware of what we were trying to accomplish. Needless to say. liquor liscenses the were denied, three (3) days before the rodeo was to take place. At. which time Church Hi11 County immediately filed an injunction to halt the "GAY" rodeo. This was approximately at. 1:30p.m., two (2) days prior to the rodeo. Their reasoning behind the injunction was citing a Nevada law requiring any gathering of more than 1000 people, must have a permit 60 days prior to that event. Hearing were held morning before Friday the rodeo was to take place and the judge issued a restraining order to halt the rodeo. At which time the A.C.L.U. of Nevada rushed to Carsosn City. to the Nevada Supreme Court, to try to overturn the restraining order

FACT #6: The A.C.L.U. of Nevada is filing SEVERAL suits against Church Hill County. One suit is a Class Action suit which claims damages for any person who traveled to Reno for the rodeo. These pepole must prepare a list for their individual state to submit to trustee the A.C.L.U. lawyers for their traveling expenses, room expenses, food, any expenses incurred in order to get to Reno, and any expenses or losses that would not accurred except for the fact that these people went to Reno.

The details of these suits are not yet available. A questionair is being prepared by the A.C.L.U. lawyers and will be sent to ALL state trustees, who will see that anyone involved in these Class Action Suits will be contacted.

The following are my thoughts on what happened in Nevada, which is something that could happen anywhere...even Colorado.

Rodeo Finals is an expensive situation and one that is difficult to keep out of the public's eye! If we, as contestants, want to hold a finals, we will have to take more responsibliity for the tunding of our rodeos; which in turn will make other less controversial sites available.

is Colorado not much different from Nevada. We were turned down by approximately eight (8). different arenas we held our before first The Aurora Horsemen's rodeo. Asociation is NOT excited with our use of their arena (Coal Creek Rodeo Park). They could file an injunction to stop us just as Church Hill County did in Nevada.

We must strengthen ourselves organization as an both locally and internationally. Internal battles will continue to erode our unity and our ability to be a constructive force in the well being of the gay community! We must ALL compromise to reach workable agrements that benefit OUR community.

The following imformation is form articles in the Nevada Newspaper--A.C.L.U. Executive Director, Ms. Shelly Chase and exiting I.G.R.A. President, Les Krambeal!! Also please note, I was misquoted in the Nevada Newspaper; which leads us to question the articles to begin with!!

We will up date you as often as we can to get additional information to you.



# EDITORIAL COMMENT

As you are all now painfully aware, the International Gav Rodeo Association and all of its member associations. are currently entrenched in what will. However, this incident has also reminded me that as we fight back against discrimination from the outside world, it is extremely importent that we remember not to discriminate in our own world.

During times of crisis, the international gay community has always banded together to defend its own. The point here being that without a united effort, from the entirety of our community we can achieve nothing.

We need to begin with ourselves and remember that it doesn't matter who we are, what are interests are, how we dress, our the things we are involved in, we are a community of like individuals, and without the support of each member, we cannot and will not achieve what we need as the whole.
