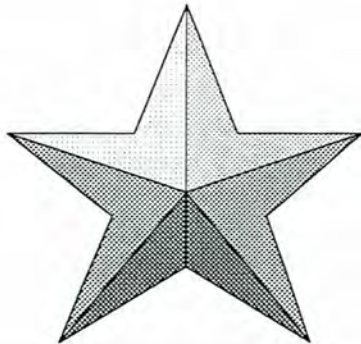

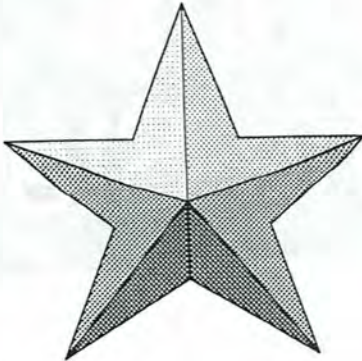
CGRA Bylaws or more information about the contest please call Vince at 303-399-6057.
