## MEMBERSHIP FROM CD S.

Elections for the new BOD for 2010 are already history – and no, it's not December – yet! I want to thank you for allowing me to serve as your membership chair for another year. I chose to run for this position as I had a few loose ends I wanted to tie up relative to the membership changes that have been implemented. I have not been happy with the painfully slow process of obtaining and distributing the membership cards. Stay tuned as I have an idea to speed that up.

#### Here's that little reminder about what's new in the by-laws for MEMBERSHIP and how it affects you:

1.) All memberships are now based on calendar year quarters instead of months. This translates to just four (4) renewal dates per year. Those of you who joined or renewed in the last half of 2008 - your membership expiration dates have been adjusted to reflect either a 9/30/09 or a 12/31/09 date. Those of you who have joined or renewed since Jan. 1, 2009 - your expiration date will be either 3/31/10 or 6/30/10. As an example, if you renewed your membership in February '09 – your expiration date will be 3/31/10 not 2/28/10. Your membership card (once you get it) will show this date.

2.) Since it should be much easier for everyone to KNOW when their membership is up for renewal, members will be DEACTIVATED in the database within 30 days of expiration if they have not renewed. ABSOLUTELY NO EXCEPTIONS!

3.) We now have a limited JR. membership category at a reduced annual fee of \$12.

From the Department of Redundancy Department, please do take a moment and make sure your membership is up-to-date. Prompt renewals are always greatly appreciated and be sure to let me know if you have any name, address, phone or email changes in need of correction and/or update. There is a large list of folks whose memberships will expire at the end of September – essentially everyone who's renewal date is July, August or September. I have sent out a "renewal reminder" email to EVERYONE on that list; and, I'll repeat the email again in early October – and probably one more time before I de-activate anyone. Staying on "Active" status is imperative for event registration. Anyone going to FINALS?
