



Proof of participation.

Remember, funds are minimal, therefore you will not be reimbursed for all trip expenses. Funds for 1995 of \$1200 will be distributed to each applicant on an event basis divided by total events for all applicants, but not to exceed 50% of expenses incurred by a contestant, per GSGRA Standing rule Article X Rule 10.2.


#### WILLIAM B.(BILL) CHOWN
