If a rodeo secretary is unable to verify current membership from lists provided by Associations or from membership cards carried by the member, *THE CONTESTANT WILL BE REQUIRED TO JOIN AN ASSOCIATION IN ORDER TO COMPETE*. Bottom line, carry your membership card at all G.S.G.R.A. and/or I.G.R.A. Rodeos and other functions, without it you may have to pay for membership again and membership fees paid will not be refunded.

THE RESPONSIBILITY IS NOW YOURS.

The Membership Committee will continue to provide each rodeo with a valid membership list two weeks prior to the rodeo but we cannot and will not be responsible for last minute renewals which do not appear on this list.All members receive a reminder notice approximately 45 days prior the membership expiration date. If you don't want problems at registration, carry you card and renew as soon as you get your renewal notice.

BUDDY PASSES

G.S.G.R.A. has a statewide agreement regarding Buddy Passes. The following should help you understand what they mean to you and how they work.

To qualify for a Buddy Pass the contestant must be competing in at least one rough stock or horse event. Contestant only competing in Roping on Foot or Camp Events do not qualify for a Buddy Pass.

Your Buddy must sign a liability waiver and must comply with, and be subject too, all rules governing the rodeo including the dress code. You, the contestant, can and will be held responsible for the actions of your buddy up to and including your disqualification.

The cost of the Buddy pass can, and will vary from one rodeo to another based on the social events included with the pass.

Please help us run better rodeos for everyone by not asking us to bend the rules.
