

If there ever was any doubt, let's put it to rest once and for all! Membership, in good standing, in an IGRA Member Association is required to complete in IGRA and/or GSGRA sanctioned rodeos.

- 1. Valid membership cards are accepted as proof of membership. G.S.G.R.A. white, credit card style membership cards qualify for this recognition.
- 2. If the rodeo secretary is unable to verify your current membership from the list provided by G.S.G.R.A. or from your membership card, you will be required to join an association in order to compete.

Bottom line, carry your membership card at all G.S.G.R.A. and/or I.G.R.A. Rodeos and other functions, without it you may have to pay for membership again and these fees may not be refunded.

THE RESPONSIBILITY IS YOURS.

The Membership Committee provides I.G.R.A. with an updated membership list on the 15th of each month. To be sure you will not have membership problems at registration, mail your renewal so that it will be received by us on or before the 15th of the month prior to the rodeo. G.S.G.R.A. cannot and will not be responsible for last minute renewals which do not appear on this list. All members receive a reminder notice approximately 45 days prior the membership expiration date. If you don't want problems at registration, RENEW AS SOON AS YOU GET YOUR RENEWAL NOTICE.

Bylaws - Bylaws - Bylaws

International - State - Chapter

All members of G.S.G.R.A. are entitled to a copy of the bylaws of G.S.G.R.A., the bylaws of the chapter with which they are affiliated and the bylaws of I.G.R.A. We have found that most members do not want these copies so, in the interests of economy and the ecology, copies of bylaws are provided only on request.

All receive a copy of the I.G.R.A. rule book so please do not ask or bylaws just to get rodeo rules. (Let's not kill any more trees than we absolutely have to!)

The bylaws of G.S.G.R.A. are many pages long and the I.G.R.A. bylaws are even longer. Printing and postage costs at more than \$10.00 per set prohibit general distribution. We ask that you only request the bylaws you actually need and that you enclose three dollars if you are requesting the bylaws of only one organization and

five dollars if you are requesting the bylaws of both organizations to help cover the cost involved. Checks should be made payable to G.S.G.R.A. No cash please. All requests for copies of the bylaws will be honored with or without a donation.

Remember that the bylaws of I.G.R.A. are for the International Rodeo
Season and are amended only once a year at the International Convention.
This means that I.G.R.A. bylaws serve until the end of October and the revised bylaws from convention take effect on November 1.

G.S.G.R.A. and I.G.R.A. bylaws may be ordered from the address below. For Chapter bylaws please contact your Chapter Bylaws Chair of Chapter Secretary.
